

States asked to enforce 'country of origin' display on products, says Paswan

CONSUMER AFFAIRS MINISTER Ram Vilas Paswan on Thursday said state governments have been directed to strictly enforce the provision that requires companies and e-commerce players to display the 'country of origin' on all products.

The provision of declaration of 'country of origin' has been in place since January 2018 for all manufacturers, importers, packers and e-commerce players. The commerce ministry has now been asked to ensure that e-commerce players too comply with this rule strictly, he said.

"We have reiterated that we have such a provision in place. We have directed state governments to strictly enforce the provision and take action against violators," Paswan told reporters.

Whether a product is sold through offline or online platform, it is mandatory to display 'country of origin' besides other details like maximum retail price (MRP), day of ex-

piry, net quantity and consumer care details, he said.

In January 2018, the government amended the Legal Metrology (Packaged Commodities) Rules, 2011 to add a new provision mandating declaration of 'country of origin' for manufacturers, importers, packers and e-commerce entities. Consumer Affairs Secretary Leena Nandan said most of the companies are complying with the provision on product labelling sold in offline markets. But, e-commerce platforms are not showing it prominently on their websites. If this provision is strictly complied with, con-

sumers can make an informed decision.

"All e-commerce sites have to display it on their website. We have written to DPIIT, which registers e-commerce sites, to comply with the provision," she said, adding that discussions are on with the Department for Promotion of Industry and Internal Trade (DPIIT) on this issue.

The provision for declarations on e-commerce sites is made under sub-rule 10 of rule 6 of the Legal Metrology (Packaged Commodities) Rules, 2011, she said.

On penal action against violators, the Secretary said Section 36 of the Legal Metrology Act provides penalty of up to Rs 1 lakh and also an imprisonment for a term of one year.

To address the consumer concerns, the Secretary mentioned that the Central Consumer Protection Authority (CCPA) has also been set up with the Consumer Affairs Department's Additional Secretary as chief commissioner and Bureau of Indian Standards (BIS) Director General as investigation officer.

Migrant workers' issue: SC pulls up Maha govt for claiming all is fine

THE SUPREME COURT Thursday pulled up the Maharashtra government for claiming that every thing was fine on the issue of migrant workers and said that it is the duty of the state to find out shortcomings and lapses wherever found and to do the needful.

A bench of Justices Ashok Bhushan, Sanjay Kishan Kaul and M R Shah said it does not "appreciate the tenor" and the claims made and asked the state to file a fresh affidavit listing the steps taken to mitigate the problems of migrant workers amid the Covid-19 crisis.

"We have gone through the affidavit filed by the State of Maharashtra dated July 6, 2020. We do not appreciate the tenor and the claims made in the affidavit filed on behalf of the State of Maharashtra.

"The present is not an adversarial litigation and it is the duty of the State to find out shortcomings and lapses wherever found and to do the needful. The State cannot claim that unless the State is informed of the materials, it cannot reply or act," the bench said.

Praj Industries forays into renewable chemicals and materials industry

PRAJ INDUSTRIES IS expanding into the global bio-based renewable chemicals and materials (RCM) industry. RCM products are based on a variety of feedstock from agriculture, forestry and dairy and it is an alternative to chemicals and materials sourced from fossils. Praj is also getting into new business models where it will not only provide technology, design and deployment but also make strategic investments in the companies that would be manufacturing products using bio-renewable chemicals and materials.

Pramod Chaudhari, executive chairman, said there was nothing that the biotech could not do and there was a renewable alternative for everything. RCM produced from bio-based feedstock are sustainable alternatives to products made from fossil resources and around 90% of the chemicals made from fossil resources can be made from renewable resources, Chaudhari said. With this, Praj was pole-vaulting into a league of select companies worldwide that are present in the RCM business. According to Chaudhari, the chemical industry worldwide is estimated to be worth \$25 trillion annually and renewable chemicals have a potential to replace a majority of chemicals that are currently

sourced using fossil resources. The RCM industry worldwide is estimated to have reached

\$65 billion and over a decade, is likely to cross around \$200 billion at a CAGR of 11-12%.
