

After a lull, Karnataka records 1,116 new cases

Bengaluru: After a brief respite of five days, when the state recorded less than 1,000 cases daily, Karnataka saw a sharp spike, registering 1,116 new patients and taking the state tally to 29,64,083. Active cases increased from 15,754 to 15,892. Bengaluru saw the highest addition in cases since July 9 (472 cases), with 462 cases taking the city's tally to 12,42,332. Active cases saw the highest percentage increase in the city, at 2.69 per cent, with the number going up from 7,136 to 7,328. The state's positivity rate, however, reduced from 6.50 per cent to 6.48 per cent. Though recovery rate reduced on September 14, it picked up on Wednesday to 98.19 per cent, with 1,034 discharges. The capital's recovery rate, however, decreased from 98.13 per cent to 98.11 per cent. The state's mortality rate remained at 1.26 per cent, with eight deaths taking the toll to 37,529. Bengaluru's mortality rate remained at 1.29 per cent, with five deaths taking the city's toll to 16,065. ENS

Vax drive goes smooth for lactating mothers

Have to undergo counselling, check-up; beneficiaries monitored for 10 days after jab

WITH reducing hesitancy among pregnant and lactating women in getting the Covid-19 vaccine, the inoculation drive in Bengaluru is going slow but steady. Bruhat Bengaluru Mahanagara Palike plans to extend the drive from three days a week (Monday, Wednesday and Friday) to all days, besides setting up vaccination sites in all 20 maternity homes coming under the corporation. Ever since the drive began on July 27, 3,701 pregnant women and 830 lactating women were vaccinated with one dose in Bengaluru, until September 14. These beneficiaries were vaccinated in 12 public health centres, including six referral hospitals, three urban primary health centres (UPHC), one community health centre, Vani Vilas Hospital and Gosha Hospital, with

either Covaxin or Covishield. The drive is more time-consuming with these women, as they have to undergo screening, counselling and a check-up. "We screen pregnant women for being high-risk patients, be it those with BP, sugar or other abnormalities. If they are at risk, vaccination is delayed by a few days. After screening, they are counselled about the vaccine and possible after-effects. This is followed by a gynaecological check-up, post which they are given the jab," a BBMP health official said. The process does not end here, with the vaccine beneficiary being monitored for the next 10 days. The vaccination site informs the field staff at UPHCs, who in turn inform ASHA workers and ANMs, who call or visit the women. The vaccination sites also follow up with the beneficiary. To ensure the process is done efficiently, the drive is currently on a smaller

scale. When women come for antenatal checkups at government hospitals, awareness is created on getting the vaccine. "In the first week, the drive was slow but now it has picked up. There is a set protocol in place and only those eligible are vaccinated. We don't open the counter and wait. Instead, we reach out to the beneficiaries and bring them to maternity homes. There is less hesitancy now," said Dr Randeep, Special Commissioner, Health, BBMP. Vani Vilas Hospital, where 511 pregnant women and 124 lactating mothers have received the jab, it is observed that more women are coming forward to take the Covid vaccine now, said Dr Santosh D Prabha, resident medical officer. Almost 10 to 15 people come per day and even those admitted in hospital wards are coming forward, with staff nurses doing their part by counselling patients.

Covid vaccination at doorstep of villagers

HASSAN: The district administration has started a special drive to job people at their doorstep to achieve 100 percent vaccination at the earliest. The health department has formed special teams comprising a senior nurse, an ASHA worker and health assistants for the purpose following the direction of DC R Girish who is keen on achieving the goal at the earliest. The team of health staff is planning to visit 100 villages in each taluk for vaccination in the first phase. Data says 1,335 people have died due to Covid in the district. There are 562 active cases and 1.10 lakh people have recovered so far from Covid in the district. Now, people are getting vaccination immediately after visiting vaccination centres as the health department set up more such centres at taluk and hobli levels 15 days ago. Elected representatives and senior officials had tried to influence the vaccination drive on many occasions when there was shortage of the vaccine.

Microbiologist, dad test negative for Nipah

Mangaluru: The Nipah virus test result of a 25-year-old microbiologist, isolated at District Wenlock Hospital in Mangaluru, has come negative. Confirming this, District Health Officer (DHO) Dr Kishore Kumar told TNIE that samples of the youth's father were also sent for Nipah test to the National Institute of Virology (NIV) in Pune, and had returned negative. However, both of them will have to stay in hospital for seven more days as his father has tested positive for Covid-19. The DHO said that since the son is the primary contact, he has to stay in hospital too. The microbiologist, employed with a Goa-based company that manufactures Nipah and Covid-19 test kits, had expressed fear that he may have contracted the Nipah virus, after which his and his father's samples were sent for testing. The youth had travelled from Goa to his hometown Karwar on a two-wheeler on September 8, during which he got drenched in rain and got a severe headache and fever. This led him to panic and suspect that he has got Nipah. He approached a hospital in Karwar, and from there, was shifted to the Mangaluru hospital in an ambulance. ENS
