

### PRIVACY POLICY

The Privacy Policy governs the use of this website www.shriramhousing.in ("Website/Site") of Shriram Housing Finance Limited ("Shriram Housing /the Company/ We") and Shriram Housing values the privacy of the user of the Site, borrowers, employees, service providers, vendors, co-lenders, and all other natural persons whose personal data may be collected by the Company ("Individual/You").

By recording your consent through the Website, on an application form, or through other means, You confirm that You have the capacity to enter into a legal binding contract, have read, and understood the Privacy Policy, and consent to the collection, storage and processing of your Personal Data, including SPDI (*as defined below*) under the terms hereof.

All or any personal information so provided will be as and on basis and the Company shall not responsible for the authenticity of the personal information supplied by you. This personal information which is provided is collected from you and solely used for the purposes connected with the terms of use which has been agreed by you, in order to provide various services by the Company.

### **Information Collected**

All personal data including 'sensitive personal data or information' as defined under applicable law ("**Personal Data**") that we collect about you will be recorded, used, and protected by us in accordance with applicable data protection legislation and this Privacy Policy. Personal Data, for purposes of this Policy, shall include that identifies you, such as your Name, Date of birth, Bank Account details or Credit Card or Debit Card, Phone number, Fax number or email address etc.

In the course of providing services through the Website and other interactions between Shriram Housing and you, we collect the following information:

- (a) From users of the Site: Shriram Housing is committed to protecting your privacy and working towards offering you a powerful, safe, online experience. Our website www.shriramhousing.in does not collect personal information about individuals except when such individuals specifically provide such information on a voluntary basis which information will not be sold or otherwise transferred to unaffiliated third parties unless otherwise stated at the time of collection or with the approval of the Individual as the case may be.
- (b) From employees, consultants and other personnel, including prospective employees: Shriram Housing may during the course of its business, appoint an Individual as an employee or a consultant. During the course of employment with Shriram Housing, Personal Data essential for the purpose of the Individual's appointment will be collected to from them. This Personal Data will not be transferred to any unaffiliated party/ies unless otherwise stated at the time of collection or with the approval of the Individual as the case may be.
- (c) From third-party vendors, service providers, DSAs, etc: Shriram Housing may during the course of its business, engage various third party vendors, service providers or DSAs. During the course of engagement with Shriram Housing, Personal Data related to the Individual will be collected, however this Personal Data will not be transferred to any unaffiliated party/ies unless otherwise stated at the time of collection or with the approval of the Individual as the case may be.

# **Use and Disclosure of Personal Data**

Shriram Housing collects personal information and SPDI from different categories of individuals for the following purposes:



- (a) For users of the website: Providing and enhancing services on the Website, fulfilling requests for products and services offered and subscribed, communicating, including through delivery of administrative notices, alerts, advice, about products and services offered and subscribed, and personalizing your experience.
- (b) For borrowers: Processing loan applications, managing accounts, verifying identity, and complying with regulatory requirements.
- (c) For employees: Managing employment records, payroll, and benefits administration.
- (d) For service providers and vendors: Contract management, due diligence, and meeting regulatory and operational requirements.
- (e) For co-lenders and DSAs: Supporting loan processing, servicing, and customer engagement.
- (f) To share with group companies and other third parties in so far as required for joint marketing purposes and / or to similar services to provide you with various value-added services.
- (g) For market research, project planning, troubleshooting problems, detecting, and protecting against error, fraud or other criminal activity.
- (h) To third-party contractors that provide services to the Company and are bound by these same privacy restrictions.
- (i) To the extent necessary, for any regulatory filing or for responding to government authorities, to establish and pursue claims or defend against claims, responding to judicial process and provide information to law enforcement agencies, for any other purposes that are permissible under applicable law.
- (i) To enforce SHFL's Terms of Use.

Shriram Housing treats your Personal Data or your use of the service as private and confidential and does not check, edit or reveal it to any third parties except where it believes in good faith, such action is necessary to comply with the applicable legal and regulatory processes or to protect and defend the rights of other users or to enforce the terms of service which are binding on all the users of www.shriramhousing.in Shriram Housing and/or its affiliates will share / sell some or all of the Individual's personal information with another business entity, should the Company (or its assets) plan to merge with, or be acquired by that business entity, or re-organization, amalgamation, restructuring of business. In the event such a transaction occurs, that other business entity (or the new combined entity) will have your consent to process Personal Data, including SPDI, under this Privacy Policy or such other policy as may be published by the new entity.

Except where specifically agreed or necessary for operational or regulatory reasons, Shriram Housing will not send you any unsolicited marketing communication. If you do not opt out, Shriram Housing may use any of your e-mail addresses to send occasional e-mails pertaining to information on product and services. Individuals, who believe they are receiving our communications in error or no longer desire to receive them, should inform us at Contact@shriramhousing.in and we will remove those names from our mailing lists. Shriram Housing will be judicious in the use of e-mail and paper mail to communicate with users.

The Individual can nevertheless unsubscribe from receipt of such e-mails by following instructions herein. Shriram Housing may collect statistics or other information, which does not personally identify



you. Shriram Housing reserves the right to perform statistical analysis of user behaviour and characteristics in order to measure interest in and use of the various areas of the Site and to inform advertisers of such information as well as the number of users that have been exposed to or clicked on their advertising banners. We will provide only aggregated data from these analyses to third parties.

#### **Information on Website**

## **User Rights**

The Individuals have the right to:

- (a) withdraw consent from the collection, processing, and storage of Personal Data, which must be withdrawn in writing and in accordance with the terms of the Privacy Policy. Withdrawal of consent will not be retrospective in nature and shall be applicable prospectively;
- (b) request a copy of the Personal Data held by the Company;
- (c) request deletion of Personal Data in the Company's records; or
- (d) request changes to Personal Data.

These rights may be exercised by contacting the Grievance Officer, as set out herein.

You have the option not to provide or agree to the collection of Personal Data. In case Personal Data or consent for usage of Personal Data is not provided, or consent is subsequently withdrawn, the Company reserves the right to discontinue the services for which the said information was sought or modify the terms of your employment.

The aforementioned rights will not be available in respect of any Personal Data or information which cannot be corrected or amended pursuant to any applicable law, law enforcement requests or judicial proceedings or the like.

In the event an update to the Personal Data or modification is not verifiable by the Company, or leads to such information being incorrect, the Company will be unable to provide the Individuals with access to our Website or the services.
