

## Shriram Housing CFO bags 2 awards for liquidity and leverage management

**Mumbai, July 14, 2021:** The Chief Financial Officer (CFO) of Shriram Housing Finance Ltd (SHFL) G.S. Agarwal has bagged awards in two categories of the CFO Vision & Innovation Awards 2021.

The jury has nominated Mr. Agarwal for awards in 'CFO Innovation for Liquidity Management in BFSI' and 'CFO Innovation for Leverage Management in BFSI' categories. The awards were conceptualized by Transformance Forums and presented by Franklin Templeton.

Commenting on receiving the awards, Mr. Agarwal said: "I feel privileged to be named for recognition in two categories in the CFO Vision & Innovation Awards 2021. The role of a CFO is becoming more and more challenging and managing liquidity along with risks has become a formidable task.
